Lessee must attend drill specific calibration and safety class arranged by the Fleming County ANR Extension office.

Lessee may schedule use for up to two consecutive days.

Rental Rate: \$200. Day begins at 8am, ends at noon the following day. Late fee \$200.

Lessee agrees to be responsible for any damages to the no-till drill while in its possession. NEVER MAKE SHARP TURNS OR DRIVE ACROSS EXPOSED ROCKS WITH THE DRILL IN OPERATING POSITION.

Cleaning Fee: Lessee is responsible for returning the equipment in the same condition as it was picked up. Seed boxes and tubes must be clean and mud or other debris removed. A fee of \$200 will be assessed if not returned in clean condition.

Lessee agrees the no-till drill is to be used only in Fleming County, Kentucky and not to be sub-leased or used for any "for profit" or "custom" application.

Payment of day rate due upon signing the agreement.

No fertilizer is allowed in the drill

Lessee will tow the drill from and to the Fleming County Fiscal Court Road Department. A 50 HP tractor or ¾ ton truck or larger is required for towing.

Lessee will provide any needed hydraulic adapters.

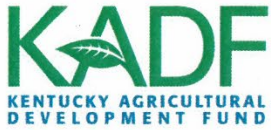
Lessee agrees to hold harmless the Fleming County Fiscal Court, employees, officers or volunteers for any liability for death, disability, personal injury, loss or damage to property that may result from the use of the no-till drill.

Lessee agrees to carry liability insurance covering its use of the no-till drill

Lessee agrees to allow representatives of the Fleming County Fiscal Court to enter the premises occupied by the no-till drill to inspect the equipment or remove it if the lessee fails to return on schedule in such case the lease will be terminated, late fee assessed, and lessee may lose rights to future use.
